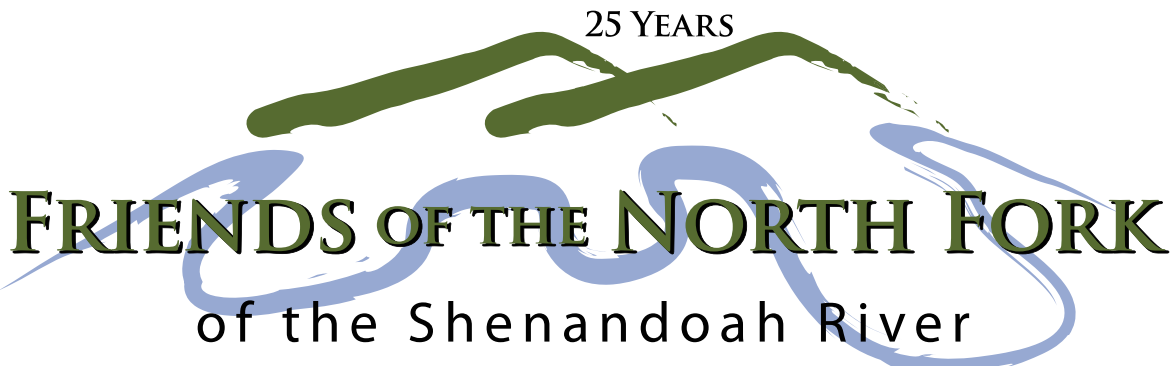

Fracking Update

The Forest Service is preparing to release its management plan for the George Washington National Forest (GWNF). Initial versions of the plan maintained a moratorium on horizontal drilling (hydrofracking) in the GWNF; however, heavy push back from the gas industry and from VA government has placed the moratorium in jeopardy. Opening the GWNF to hydrofracking could expose the headwaters of the North Fork of the Shenandoah River and the surrounding communities to potential devastating water pollution and impacts on the rural character and infrastructure of these agricultural and forested regions. **Please stay tuned for Email Action alerts in late August or early September, as we will need your help to fight for maintaining the ban if it is lifted. North Fork Explorations - One Workshop for Teachers and Two Week Long Camps for Middle and High School Students - Learning and Having Fun on the North Fork!

Once again, our summer camps and workshop for students and teachers – the North Fork Explorations – were enormous successes. **Funded by grants from the Chesapeake Bay Restoration Fund (from fees for the VA license plate with the crab) and the Chesapeake Bay Trust (Maryland’s license plate fund) and a grant from the New Market Rotary and Kennametal Foundation**, teachers and students toured the North Fork Shenandoah River watershed by bus, van and canoe – learning about watershed stewardship via hands on and interactive activities.

We had an incredible group of teachers this year from public and private schools throughout the watershed. Each individual brought loads of enthusiasm, questions, and a yearning to learn all they could about the river and its use as a teaching resource. For some it was even an opportunity to conquer a fear of canoeing! This year we asked the teachers to write their reflections on their experiences – some excerpts of some of their writings are below:

“Your class was wonderful. The presentation about water quality in the afternoon made me realize how important it is to make information meaningful. Testing the water ourselves on the second day helped to make the data come alive.”

“I was truly amazed at what new interesting facts and ideas I had when I left after our field trips. It was truly an honor to be a part of this experience and to have met all of you. Thank you for sharing your love of the river with us. It has totally changed how I look at what I do every day and how it affects not just the river but my life. This program was fantastic and I will inform other teachers about it in the future.”

“The three-day workshop has been one of the most valuable I have attended in all my years of teaching!”

“The whole experience this week was amazing. I

learned so much and.... I conquered my fear! When I signed up for this class, my goal was to make me a better teacher, never realizing the impact it would have on me personally!”

The students had a fabulous experience as well and glowing words for their Exploration time as well. Their week included a canoe trip, a fish shocking demonstration, fishing, macroinvertebrate hunting and closed with great opportunity to learn how to create a presentation in which they were able to record their activities and experiences for the week. Mom and Dad Wolf are monitors as well, substituting when Skylar was away. And now, Skylar is passing on his monitoring duties to his younger brother, Trevor. Monitoring is a family affair at the Wolf household and we at Friends are grateful for the time and effort the Wolfs and ALL of our volunteer monitors contribute to our water quality monitoring programs. Friends mentors H.B. Lantz and Joan Chapman have been working for the past two years on water related research projects with students at the Massanutten Regional Governor's School. Emilie Taft worked with H.B. on a study of nutrient levels in Stoney Creek above and below the Georges Chicken waste treatment facility effluent pipe in order to measure changes in water quality related to a major upgrade to the facility. Emily also worked with H.B. to do a short benthic macroinvertebrate study on Stoney Creek. This was a great opportunity for a student to make use of the water quality data that volunteer Lee Dieter has been col-

lecting along Stoney Creek for more than 10 years. And it was a great opportunity for Emily to make pertinent use of the knowledge she acquired related to statistics and data analysis. Thanks to H.B. and thanks to Joan for volunteering to share their expertise and time with these students and Good Luck! to Emily who's off to SUNY College of Environ. and Forestry.
